Initial the following statements to indicate that you have read them, understand them, and agree to abide by them:

___ Information that I submit as part of my application, including my insurance certificate and applicable licenses, may be shared by CWFM for purposes of promoting and managing the market.

___ I guarantee to sell only products that my family or I have raised or produced. (The Market Board may grant exceptions, but no exceptions should be assumed.)

___ The Cheyenne Winter Farmers Market has the right to refuse the marketing of any produce or products, and the right to reject any vendor.

___ Wyoming Resident Food Vendors only: If I sell unlicensed food products, I ensure these products fully comply with the Wyoming Food Freedom Act (WFFA) and I will fully inform the end consumer that the product is not certified, labeled, licensed, packaged, regulated, or inspected.

___ All food vendors (raw and processed foods): I will obtain the City of Cheyenne Food Wagon - Stand Permit and submit a copy to CWFM prior to attending market.

___ All food vendors: I understand and agree that packaged Foods that are not properly labeled shall not be sold at market. CWFM requires that all packaged foods, even those foods produced under WFFA, must be labeled according to the guidelines set forth within the Wyoming Food Safety Rule.

___ I agree to accept the space assigned to me by the Market Manager. Most, but not all, booths will accommodate an 8 foot display table, and will be 9 feet long by 7-8 feet deep. Due to the severe space limitations of an indoor market, not all booth spaces are equivalent.

___ I agree to purchase **commercial general liability insurance that meets the requirements as outlined in "Vendor Rules CWFM 2021"**. Additionally, I agree to provide a Certificate of Insurance listing Cheyenne Winter Farmers' Market as an additional insured prior to attending market. My pre-paid booth fees will not be refunded if I fail to provide an approved certificate of insurance prior to market.

___ I or my employee will check in with the market manager at the beginning of each market before setting up for market and should arrive no later than 8:30 AM. Habitual latecomers may have their booth permanently relocated within the market or have attendance privileges revoked without refund.

___ It is my responsibility to know and abide by all applicable laws and regulations governing my

product and business, including remittance of sales tax.

___ I have read and agree to abide by all market rules as set forth in "Vendor Rules CWFM 2022".

___ The application, insurance certificate and any licenses must be in the same business name as listed on page 1 of this application and turned in with the application if available now. Otherwise, documents must be received 72 hours prior to market.

Fees:

- **A sales fee**, 5% of gross sales, is payable at the end of each market. Minimum sales fee, per booth, per market, is \$10.
- **Booth Fees** are \$35 per booth, per market. Booth space will not be confirmed until booth fee is paid. Booth fees are not refunded for any reason including failure to attend, even for weather.
- **Do NOT send booth fees now unless instructed to do so by Market Manager - you will be invoiced.**
- **Early-Bird Booth Fee:** ONLY for Returning Vendors in Good Standing: (not for wait-listed Vendors, ask if unsure): \$30 per booth, per market **IF attending at least 9 markets AND payment is received in full by May 31, 2021** (Send payment now. Credits, if any, may be deducted from payment).
